What happens after I send the TCC Tribal Enrollment Program my application?

TCC Tribal Enrollment does not determine or decide eligibility, we manage a large database of files and provide Tribal membership cards to members of the Tribes we serve. With our database, experience, and connections we process the applications, then forward to the Tribe for consideration at their scheduled council meeting. For questions about the date and time of the next Tribal Council meeting, or to inquire about a Tribal decision, please contact the Tribal Office. Tribal Councils will notify TCC Tribal Enrollment only with the final enrollment decision. Only when TCC Tribal Enrollment has a completed file (1. Tribal approval resolution 2. Application 3. birth certificate; and other requested documents) can we print a Tribal membership card.
