## TERMS, CONDITIONS AND RESTRICTIONS

The following Terms, Conditions and Restrictions are accepted by the enrollee and his/her custodian once the Class E stock is received:

- Class E stock shall be life estate which means upon death of that shareholder, the stock is cancelled without compensation to the heirs.
- Class E stock and the right to receive dividends and distributions may not be sold, pledged, assigned in present or future, transferred by gift, even if restrictions on transfer end for Class A, B, C, D, or E stock.
- Class E stock cannot be voted until the shareholder reaches the age of 18.
- Class E shareholders may not now nor in the future own stock in another village corporation unless the other village corporation stock is obtained by inheritance, gift, or purchase.
- Class E shareholders may not now or in the future disenroll in Gana-A'Yoo, Limited.
- Class E shareholders may not now nor in the future be tribally enrolled to Arctic Village, Venetie, Tetlin or Metlakatla.
- Class E stock will revert to Gana-A'Yoo, Limited without compensation if it is later determined that the recipient was not eligible to receive the stock or violates any condition holding the stock.
- Each prospective holder of Class E shares of Settlement Common Stock shall provide proof of heritage sufficient to requirements set by the Board of Directors to qualify for issuance of Class E Settlement Common Stock.
